

## Wonderland Farms Goldendoodles Puppy Contract

### Conditions of sale:

We want all of our adult dogs and puppies to have healthy and fulfilling lives. According to our legal council the terms of this contract are necessary to help us do just that. It also allows all of us to understand our mutual obligations to each other. To pick up your puppy you will be required to sign this on the day of pick-up.

**Guarantee of Health and Quality** - Wonderland Farms Goldendoodles guarantees that at the time of adoption, the puppy has been checked by a licensed veterinarian and is in good health. Wonderland Farms has taken all reasonable care to ensure that all of our pups are as healthy as possible with good genes and pre-training. As with many living beings there are unpredictable cancers, foreign body ingestion, behavioral issues, accidents, ear infections and UTIs. These risks are considered normal of pet ownership and buyer is advised to discuss risk reduction strategies with their veterinarian and to acquire private pet insurance as our guarantee does not cover the above listed items.

**Good Health** - The buyer agrees to maintain this dog in good health, supply them with our recommended food and nutrition for a minimum of 6 months, provide routine preventative health care including but not limited to inoculations, internal and external parasite treatments for fleas, ticks, and heartworms. If any of the above preventative care has not been provided, puppy guarantee will be void.

**Refund** - The buyer has three days from when the puppy is picked up from the seller to have the puppy examined by a veterinarian. Vet records must be provided to Wonderland Farms if requesting a refund. Should the puppy be diagnosed with a permanently life altering problem by a licensed veterinarian within three days of puppy pick up, Wonderland Farms Goldendoodles will refund the purchase price in full after the puppy is returned to the seller, minus any reasonable transportation costs. Any request to return the puppy to the seller for a full refund must be made within this time period and may only be requested should the dog be diagnosed with a health issue where the quality of life of the dog will be shortened or seriously altered and the prognosis sent to Wonderland Farms by a licensed veterinarian as outlined in the Puppy Guarantee.

**Minor Health Ailments** - Including, but not limited to fleas, worms, or stress induced diarrhea due to the puppy's transition are not reason for the puppy to be returned to Wonderland Farms Goldendoodles.

Trupanion Pet Insurance is recommended. We have negotiated a 30 day trial for all Wonderland Farms Goldendoodle clients if you activate it within 24 hours of pick up.

**Adoption**- The buyer agrees to contact Wonderland Farms Goldendoodles should it ever become necessary to surrender the dog for adoption. If the buyer finds a suitable home that is willing to assume the obligations of the contract then the buyer will provide the new home information to

Wonderland Farms within 2 days of adoption. If the Buyer can not find a new home for the dog then Wonderland Farms will have the first right of refusal for adoption.

Unauthorized Care - Under no circumstances should the buyer surrender the dog to a shelter, humane society, rescue organization or puppy mill or Wonderland Farms may seek penalties.

Veterinary Care - Upon execution of this contract all veterinary care and associated costs of pet care are the sole and exclusive responsibility of the buyer.

Breeding - Unauthorized breeding of a Wonderland Farms dog will result in legal action, forfeiture of the dog, any puppies born from the female, and a \$50,000 fine payable to Wonderland Farms Goldendoodles immediately. The Buyer would be served by a process server and responsible for any and all legal fees and court costs associated

Fertility Care - Buyer agrees to spay or neuter their pup at one year of age unless the buyer is enrolled in our Guardianship program or the buyer has purchased breeding rights for an additional fee ranging from \$2,500-\$5,000.

Training- Buyer understands that all puppies exhibit certain undesirable behaviors such as nipping, chewing, barking, marking, etc. Buyer is responsible for appropriate training of the puppy within 6 months of purchase to correctly teach acceptable behaviors, and is responsible for proper socialization of puppy. Proof of purchasing training classes must be submitted to Wonderland Farms from a reputable vendor.

Microchip - - Wonderland Farms agrees to provide each puppy with a microchip, which will be registered to both Wonderland Farms and your family. It is your responsibility to keep the information updated. Microchips can last up to twenty (20) years but they can fail. If they fail in the first year we will send you a new one that your vet can use.

Authority to Cancel- Wonderland Farms Goldendoodles has the right to terminate the purchase of a puppy at any time before a family takes possession of the puppy. If this decision is made by Wonderland Farms Goldendoodles, all monies secured for said puppy would be returned including the deposit.

No Guarantee - We do strive to produce a certain look but we do not guarantee size, color, appearance, hypoallergenic quality, or non-shedding quality.
